The Directors of RIO LINDA COUNTY WATER DISTRICT met in the District office at 730 L Street, Rio Linda, California, on January 11, 1967, at 8:00 P.M.

The minutes of the regular meeting held on December 14, 1966, were read and approved.

On motion of Mr. Palmer, seconded by Mr. Weber, the following resolution was adopted:

RESOLUTION NO. 1-67

WHEREAS, the Board of Directors of the RIO LINDA COUNTY WATER DISTRICT desires to initiate a proceeding for the annexation to said District of the territory hereinafter described pursuant to the District Reorganization Act, commencing with Section 56000 of the Government Code:

NOW, THEREFORE, the Board of Directors of the RIO LINDA COUNTY WATER DISTRICT DOES HEREBY RESOLVE AND ORDER as follows:

Section 1 (a) Application and a proposal is hereby made to the Sacramento Local Agency Formation Commission for the annexation of certain inhabited territory to the RIO LINDA COUNTY WATER DISTRICT. The exterior boundaries of such territory are described as follows:

The West 150 feet of the South one-half of Lot 12 as shown on Plat of Elverta, recorded in the office

of the County Recorder of Sacramento County, January 23, 1908, in Book of Maps, Map No. 40.

- (b) It is desired that the proposed annexation provide for and be made subject to the following terms and conditions:
 - Authorization for the annexing District to annex the territory without notice and hearing and without election.
 - 2. Authorization for the annexing District to impose an inclusion fee of \$150.00 an acre.
 - (c) The reason for this proposal is as follows:1. To secure the servies of the District.
 - (d) The following are the affected countries, citles and districts: County of Sacramento and Rio Linda County Water District.

Section 2. BE IT FURTHUR RESOLVED that this District hereby waives the requirement of a 10-day notice of the filing of this petition and consents to the adoption by said Sacramento Local Agency Formation Commission of a resolution making determinations on this proposal without notice or hearing.

Section 3. The Secretary of the RIO LINDA COUNTY WATER DISTRICT IS HEREBY authorized and directed to file a certified copy of this resolution with the Executive Officer of the Sacramento Local Agency Formation Commission.

Mr. Griggs moved that the Treasurer of the County of Sacramento be authorized and directed to pay out money of the District in the total amount of \$1,385.03 from the Water Maintenance and Operations Fund, and in the total amount of \$4,735.29 from the Sewer Revenue Fund, as represented by requests for warrants numbered W1990 through W2006 and \$1418 through \$1439, respectively, and as represented by the respective fund schedules dated January 11, 1967, all of which requests and schedules have been signed by the president and countersigned by the secretary and signed by a majority of the Board of Directors. This motion was seconded by Mr. Palmer and was unanimously carried.

Mr. Palmer moved that the president be authorized, for and behalf of the District, to sign the contract submitted to the District by the State Employees' Retirement System for making a valuation all as set forth in said contract. Mr. Griggs seconded the motion which motion was unanimously carried.

The Board unanimously reaffirmed the policy adopted by the Board in its April, 1966, meeting relating to the disposition of time accumulated by employees in excess of forty hours per week.

Mr. Jerry Berg reported that he had met with Bruce Collins of Kennedy Engineers on Saturday, January 7, for the purpose of checking out possible defects in workmanship and material performed for and supplied to the District in the recent improvement and expansion of the Sewage Disposal Plant. Mr. Berg reported that Collins determined that the sludge pumps were not operating in a manner conforming with the specifications and requirements of the District. Mr. Berg also reported that there is a possibility of design defects in the plant and explained that he had questioned Mr. Collins as to just who was going to stand the cost of any necessary work to correct design defects. The president read a letter directed to Arntz Construction by Kennedy Engineers in which request was made for correction of reported defects.

Mr. Copeland submitted his written audit report and among other things reported that the District has operated within its budget during the past six months.

Mr. Tobey reported that he had prepared a contract for the District to be signed by Skalisky Decorators for the painting of the water tank and tower and pointed out to the Board that because of uncertain weather conditions at this time of the year no fixed date for completion was

incorporated in the contract but that there was an undertaking on the part of the contractor to pursue the work of painting with such dispatch as the weather would permit.

Mr. Griggs moved that the meeting be adjourned. This motion was seconded by Mr. Weber and was unanimously carried.

Mr. Copeland reported that the District revenue exceeded District expenses in the sum of \$1180.00 during the past month; that Water Revenue was in excess of that which was anticipated in the budget and that the Sewer Revenue was about as projected in the budget. Mr. Tobey reported on the Edwards Annexation which had been rejected by the Board of Equalization on the grounds that the description was inadequate. It would appear that henceforth the Sacramento Local Agency Formation Commission will determine whether a description of an intended annexation is adequate to enable a person, completely unfamiliar with the area, to draw an accurate boundary of the area to be annexed.

WHEREAS, the RIO LINDA COUNTY WATER DISTRICT has on deposit in its Water Maintenance and Operations Fund \$20,000.00 which will not be used or required by the District for the purposes for which it is intended for several months; and

WHEREAS, it is the desire of the Board of Directors of said District to invest \$20,000.00 in United States of America Treasury Bills maturing in ninety (90) or ninety-one (91) days from the date of purchase.

(1) The County Treasurer of the County of Sacramento is hereby authorized and requested to purchase at the offered price approximately \$20,000.00 worth of United States of America

Treasury Bills through his agent at the first offering date by the Federal Reserve Bank.

- (2) Said County Treasurer is further authorized and requested to have the said United States of America Treasury Bills held for safekeeping in San Francisco, California, for the account of the District.
- (3) The County Auditor of Sacramento County, California, is hereby authorized and requested to do such things as may be necessary to effect the object and purposes of this resolution.

The written report of Richard L. Copeland, District Auditor, was received and among other things disclosed that there were a total of all funds available to the District of \$67,749.90 of which \$10,890.56 as of May 31, 1967; that expenditures exceeded income in the sum of \$387.77 and that while water arrearages were reduced percentage wise from April, 1967, Sewer arrearages increased four points percentage wise over April, 1967.

Mr. Tobey reported that he had checked on the question of whether or not the District was authorized by law to create and fund its own pension plan and determine that the District could do such; that Section 31000 of the California Water Code expressly parmitted such action on the part of a Board of Directors of a county water district. However, Mr. Tobey stated that he had inquired of Mr. Kisuk Yang of the California State Employees Retirement System as to whether or not other districts similar to Rio Linda County Water District had initiated and funded its own plan. Mr. Yang indicated that he had no knowledge of any district creating its own pension plan but that he did know the City of Mill Valley had done so several years ago and now regretted it very much. One of the major problems that would confront the district were it to create its own pension plan is the cost of an actuarial evaluation from time to time. Mr. Yang reported that it would cost no less than \$1,000.00 each time an actuarial evaluation were made and that such would be necessary quite frequently. Other expenses incident to the self operated plan would be bookkeeping and accounting. Mr. Yang made it clear that he was not attempting to influence the district in any decision relating to an employee's retirement plan nevertheless he urgently recommended against the creation of a self contained plan by any district.

Mr. Adams reported on his meetings relating to the Local Agency Formation Commission Legislation, That is pending or proposed and stated that in his opinion and those present at the meetings a substantial increase in the power conferred on Local Agency Formation

Commissions would be granted in by the legislature. He submitted that it is not unreasonable to believe that in the future Districts such as the Rio Linda County Water District would be required to permit annexation of all or part of its property or merge with other districts at the request of the Local Agency Formation Commissions. He indicated that a dinner meeting would be held later on in the summer at which time counteraction could be planned by those districts seeking to retain some voice in matters involving annexations to or mergers of districts.

Mr. Wagner then submitted his report and among other things stated that \$1,746.51 had been paid by Elverta residence pursuant to the recent inclusion and that he anticipated an additional \$5,000.00 would be paid by residence within the next week.

The minutes of the regular meeting held on November 8, 1967, were read and approved.

The minutes of the special meeting held on November 27, 1967, were read and approved.

Mr. Griggs moved that the treasurer of the County of Sacramento be authorized and directed to pay out money of the District in the total sum of \$5.007.58 from the Water Maintenance and Operations Fund and in the total amount of \$1,021.79 from the Sewer Revenue Fund, as represented by request for warrants numbered W2225 through W2248 and \$1626 through \$1638, respectively, and as represented by fund schedules dated December 13, 1967, all of which requests and schedules have been signed by the President and countersigned by the Secretary and signed by a majority of the Board of Directors. This motion was seconded by Mr. Weber and was unanimously carried.

On motion duly made, seconded and carried, the following resolution was adopted:

RESOLUTION NO. 16-67

WHEREAS, the Board of Directors of RIO LINDA COUNTY WATER DISTRICT heretofore initiated a proceeding for the annexation by said District of a certain territory designated as "Petersen-Jones Property Annexation to Rio Linda County Water District (36-67)"

pursuant to the District Reorganization Act, commencing with Section 56000 of the Government Code; and

WHEREAS, the Sacramento Local Agency Formation Commission by Resolution No. LAFC-94, approved the proposed annexation subject to the following specified terms and conditions:

- (a) Authority for the RIO LINDA COUNTY WATER DISTRICT to annex the territory without notice, hearing or election;
- (b) Authority for the RIO LINDA COUNTY WATER DISTRICT to impose an inclusion fee of \$150.00 per acre as a condition of the annexation:

NOW THEREFORE, the Board of Directors of RIO LINDA COUNTY WATER DISTRICT hereby resolves, determines and orders as follows:

- (1) The territory designated, "Petersen-Jones Property Annexation to Rio Linda County Water District (36-67)", and particularly herein be, and the same is hereby annexed to the RIO LINDA COUNTY WATER DISTRICT without notice, hearing or election;
- (2) By virtue of the authority granted to RIO LINDA COUNTY WATER DISTRICT, there is imposed on the owners of said property an inclusion fee computed at the rate of \$150.00 per acre as a condition to said annexation.

The exterior boundaries of the territory annexed are described as follows:

- The West 60 feet of Lot 13, as shown on the "Plat of Lindamead", recorded October 20, 1950, in Book 31 of Maps, Map No. 21, records of said Sacramento County.
- (2) Lot 11, as shown on the "Map of Lindamead", recorded on October 20, 1950, in Book 31 of Maps, Map No. 21, records of Sacramento County.

On motion duly made, seconded and carried, the following resolution was adopted:

RESOLUTION NO. 17-6/

WHEREAS, the Board of Directors of the RIO LINDA COUNTY WATER DISTRICT desires to initiate a proceeding for the annexation to said District of the territory hereinafter described pursuant to the District Reorganization Act, commencing with Section 56000 of the Government Code;

NOW, THEREFORE, the Board of Directors of the RIO LINDA COUNTY
WATER DISTRICT DOES HEREBY RESOLVE AND ORDER as follows:

Section 1 (a) Application and a proposal is hereby made to the Sacramento Local Agency Formation Commission for the annexation of certain inhabited territory to the RIO LINDA COUNTY WATER DISTRICT. The exterior boundaries of such territory are described as follows:

The South one-half of Lot 10 as shown on the official "plat of Rio Linda Subdivision No. 2", recorded in the office of the County Recorder of Sacramento County, September 27, 1913, in Book 14 of Maps, Map No. 47, except the South 176 feet thereof. The acreage and dimensions of said Lot 10 are computed to the center line of a 40 foot road on the West as shown on the official plat of said subdivison.

- (b) It is desired that the proposed annexation provide for and be made subject to the following terms and conditions:
 - Authorization for the annexing District to annex the territory without notice and hearing and without election.

- 2. Authorization for the annexing District to impose an inclusion fee of \$150.00 an acre.
- (c) The reason for this proposal is to secure the services of the District.
- (d) The following are the affected counties and districts: Sacramento County and Rio Linda County Water District.

Section 2. BE IT FURTHER RESOLVED that this District hereby waives the requirement of a 10-day notice of the filing of this petition and consents to the adoption by said Sacramento Local Agency Formation Commission of a resolution making determinations on this proposal without notice or hearing.

Section 3. The Secretary of the RIO LINDA COUNTY WATER DIST-RICH IS HEREBY authorized and directed to file a certified copy of this resolution with the Executive Officer of the Sacramento Local Formation Commission.

Mr. Copeland presented his written and oral report.

Mr. Tobey reported that he had received a call from Mr. Christensen of the Sacramento Local Agency Formation Commission regarding the numerous fall parcel annexations of property to the RIO LINDA COUNTY WATER DISTRICT. He stated that the commission believed the best interests of the people would be served by requiring larger annexations and that it was the commission's desire that a representative call upon the Board for the purpose of explaining its position. Mr. Tobey stated that he was lead to believe that a representative of the Sacramento Local Agency Formation Commission would make arrangements to appear before the Board shortly after the first of the year.

Mr. Griggs moved that the District Manager proceed with the installation of gasoline engines as sources of emergency power at two well sights within the District. This motion was seconded by Mr.Ela and was unanimously carried.

On motion duly made, the meeting was declared adjourned.
