- (2) The South 1/2 of Lot 13 of Rio Linda Subdivision No. 2, according to the Official plat thereof, filed in the office of the Recorder of Sacramento County, California, on September 27, 1913, in Book 14 of Maps, Map No. 47.
- (3) Lot 4, as shown on the "Map of Clearview", recorded in the office of the County Recorder of Sacramento County, on July 28, 1949, in Book 29 of Maps, Map No. 18.
- (4) All that portion of the Northwest one-quarter of Section 20, Township 10, North Range 5 East, M.D.B.&M., described as follows:
 Beginning at a point in the center line of Elwyn Avenue, a 40 foot County Road and the West line of said Section 20, said point being the Southwest corner of that certain parcel of land conveyed to Virgil A. Chapman and wife, by Deed dated May 16, 1945 and recorded April 23, 1947 in Book 1321A of Official Records, page 474; thence, along the South line of said Chapman parcel, East 792.90 feet; thence South 01°02'30" East 274.62 feet to a point located North 01°02'30" West 220.78 feet from the North line of the Rancho Del Paso, as shown on the official plat thereof, filed in the office of the County Recorder of Sacramento County March 4, 1911 in Book A of Surveys, Map No. 94; thence, parallel to the North line of said Rancho Del Paso, West 793.10 feet to the center line of said Elwyn Avenue; thence, along the centerline of said Elwyn Avenue, North 01°00" West 274.62 feet to the point of beginning. EXCEPTING THEREFROM THE FOLLOWING:
- Beginning at a point in the center line of Elwyn Avenue, a 40-foot County Road and the West line of said Section 20, said point being the Southwest corner of that certain parcel of land conveyed to Virgil A. Chapman and wife, by Deed dated May 16, 1945, recorded April 23, 1947 in Book 1321A of Official Records, page 474; thence along the South line of said Chapman parcel, East 348.48 feet; thence South 01°02'30" East 125 feet to a point located North 01°02'30" West 370.40 feet from the North line of Rancho Del Paso, as shown on the official plat thereof, filed in the office of the County Recorder of Sacramento County on March 4, 1911 in Book A of Surveys, Map No. 94; thence, parallel to the North line of said Rancho Del Paso, West 348.48 feet to the center line of said Elwyn Avenue; thence along the center line of said Elwyn Avenue, North 01°00" West 125 feet to the point of beginning.
- (5) All that portion of Lot 25 as shown on the "Map of Rio Linda Subdivision No. 1", recorded in the office of the County Recorder of Sacramento County, California, on May 6, 1913, in Book 14 of Maps, Map No. 18, described as follows:

COMMENCING at a point on the South line of said Lot 25 and on the center line of a 60 foot public road designated on said plat as Indiana Avenue, from which the Southeast corner of said Lot 25 bears North 89°02 1/2' East (measured along the South line of said Lot 25) at the distance of 396 feet; thence, parallel to the East line of said Lot 25, North 1°46 1/2' West 330 feet; thence parallel to the North line of said Lot 25, South 89°02 1/2' West 89 feet; thence, parallel to the East line of said Lot 25, South 1°46 1/2' East 330 feet to a point on the South line of said Lot 25 and on the center line of said 60 foot public road; thence, along the South line of said Lot 25 and along the center line of said 60 foot public road, North 89°02 1/2' East 89 feet to the point of commencement.

- (6) Lot 10, as shown on the "Plat of Clearview", recorded in Book 29 of maps, Map No. 18, records of Sacramento County, State of California,
- (b) It is desired that the proposed annexation provide for and be made subject to the following terms and conditions:
 - Authorization for the annexing District to annex the territory without Notice and hearing and without election.
 - 2. Authorization for the annexing District to impose an inclusion fee of \$200.00.
- (c) The reason for this proposal is to secure the services of the District.
- (d) The following are the affected counties and districts:

Sacramento County and Rio Linda County Water District.

Section 2. BE IT FURTHER RESOLVED THAT this District hereby waives the requirement of a 10-day notice of the filing of this petition and consents to the adoption by said Sacramento Local Agency Formation Commission of a resolution making determination on this proposal without notice or hearing.

Section 3. The Secretary of the RIO LINDA COUNTY WATER DISTRICT is hereby authorized and directed to file a certified copy of this resolution with the Executive Officer of the Sacramento Local Agency Formation Commission.

Discussion was then had concerning a proposed increase of monthly salary for Donald W. Riley. Mr. Eia moved that Mr. Donald W. Riley's salary be increased from \$771.00 to \$800.00 per month effective November 1, 1972. This motion was seconded by Mr. Weber and was unanimously carried.

Mr. Adams submitted his report and among other things advised the Board that the State Water Quality Control Board had initiated a requirement that seven tests of the affluent from the Disposal Plant into Dry Creek be made each week and observed that such represented in his opinion another step in the ever increasing demands of the State. Mr. Adams also recommended to the Board that the Board authorize the acceptance of the \$3,000.00 settlement for fire damage to the Disposal Plant.

Mr. Griggs moved that the District accept the offer of \$3,000.00 in settlement of the fire loss as recommended by the District Manager and that the Board authorize the purchase of the so-called "Umbrella policy" raising the public liability limits from a maximum of \$300,000 to a maximum of one million dollars. Mr. Weber seconded said motion which motion was unanimously carried.

Mr. Copeland submitted his oral and written report and among other things observed that the delinquencies were down during the past month and that despite the rather substantial disbursements during the past month, the District broke even in its operations.

Mr. Tobey read proposed Ordinance No. 9.3 and on motion by Mr. Palmer, seconded by Mr. Weber, and unanimously carried, the following resolution was adopted:

Mr. Weber submitted his report.

Mr. Griggs moved that the meeting be adjourned and there being no objections thereto the President declared the meeting adjourned.

ORDINANCE NO. 9.3

AN ORDINANCE AMENDING SECTION 2 OF ORDINANCE NO. 9.1 SETTING FORTH AND PROVIDING FOR FEES FOR SEWER SERVICES AND PROVIDING FOR EFFECTIVE DATE OF ORDINANCE.

The Board of Directors of the RIO LINDA COUNTY WATER DISTRICT, Sacramento County, California, does ordain as follows:

Section 1. Section 2 of said Ordinance No. 9.1 is hereby amended to read as follows:

"Section 2. Monthly Sewer Services Fees. For the purpose of providing funds for payment at or before maturity of the principal of and interest on all sewer revenue bonds heretofore or hereafter issued by the District for the purpose of the acquisition, construction, improvement and financing of the District Sewer System and for the purpose of defraying the cost of maintenance and operation of the District Sewer System, there are hereby levied and assessed upon all premises having or required hereby to have any sewer connections with or discharging or required hereby to discharge sewage into or through the District Sewer System, monthly sewer service fees for the sewer services furnished or available to such premises by the District Sewer System, such fees to be payable in the following respective amounts:

1. For each structure or building outside the boundaries of the District served by the District Sewer System or any part thereof, the monthly sewer service fee shall be one and one-half (1-1/2) the fee for a similar service within the District.

Section 2. This ordinance shall take effect and be in full force forthwith upon adoption, but shall be published once in THE WORLD, a newspaper printed, published and circulated in the RIO LINDA COUNTY WATER DISTRICT within ten days after adoption with the names of the members of the Board of Directors voting for and against the same.

Leo Signorotti then submitted his written report which disclosed that delinquencies in the Water Account had risen during the past month and that the 1955 Sewer Revenue Fund was now \$2,245.50 less than the amount required insofar as it is a restricted fund. He suggested that action be taken by the Board to transfer funds from the Sewage Treatment Plant Improvement Fund to the 1955 Sewer Revenue Fund. General discussion followed concerning the amount that should be transferred at this time.

On motion by Mr. Weber, seconded by Mr. Eia, and unanimously carried, the following resolution was adopted:

RESOLUTION NO. 8 - 72

WHEREAS, there is presently on deposit in the Sewage Treatment Plant Improvement Fund the sum of \$15,042.93 of which sum \$10,000.00 will not be required for District purposes in the near future, and

WHEREAS, there is a current need for \$10,000.00 in the 1955 Sewer Revenue Fund,

BE IT RESOLVED that the sum of \$10,000.00 be transferred to the 1955 Sewer Revenue Fund Account from the Sewage Treatment Plant Improvement Fund and to effect said transfer of funds the auditor of the County of Sacramento be authorized and directed to do all acts necessary to effect a transfer as aforesaid.

Mr. Tobey reported that he and Mr. Adams had reviewed the options open to the District with respect to the malfunctioning grit removal equipment furnished by FMC Corporation pursuant to specifications prepared by the District Engineer. He reported that at this point he believed it highly advisable to obtain the expert opinion of a qualified engineer to determine whether the malfunctioning of the grit removal equipment

results from an over-design by the District Engineer which is alleged by FMC or whether in one way or another FMC has failed to supply the District equipment which it knew or had reasons to know would not effectively perform the work for which it was designed. He read excerpts from letters written by FMC personnel and by the District Engineer and explained to the Board that the District Engineer had suggested an experimental operation to determine whether the suggested solution of FMC would in fact be a solution to the District's problems. He recommended that the Board accept no part of the cost for such experimentation insofar as in his opinion the problem was one that must be resolved by either FMC or the District Engineer.

Mr. Tobey was requested by the Board to write a letter to Landis & Associates expressing the Board's opinion that any experimentation would have to be at the cost of the District Engineer and/or FMC and that the Board was currently engaged in an effort to determine whether FMC is correct in its assertion that the grit removal equipment was over-designed.

Mr. Tobey reported that he had carefully reviewed the environmental impact report and the economic study provided the County of Sacramento by its engineers relating to the proposed County wide Sewer Disposal Plant. He read certain excerpts from both documents which indicated that it would be only a short period of time before the State Water Quality Control Board would prohibit the release of affluent into Dry Greek and Magpie Creek thus terminating the use of the District's Sewage Disposal Plant. Mr. Adams then reported that the costs estimates set forth in the County's report as the same relates to the Rio Linda County Water District could be very materially reduced.

Mr. Weber submitted his report and among other things stated that a dinner meeting would be held at the Palomino Room on Wednesday November 15.

On motion by Mr. Griggs and hearing no objections thereto the President declared the meeting adjourned.
