The minutes of the regular meeting held March 11, $1981\ \mathrm{were}$ read and approved.

Mr. Dyer moved that the Treasurer of the County of Sacramento be authorized and directed to pay out money of the District in the total sum of \$24,145.06 drawn on the Water Maintenance and Operations Fund and as represented by Request for Warrants numbered W6387 through W6423, each of which has been signed by a majority of the Board of Directors. This motion was seconded by Mr. Wilson and passed unanimously.

Mr. Adams introduced the subject of ACWA/JPIA loss prevention inspections. The board discussed the subject and on motion by Mr. Palmer and second by Mr. Dyer the following resolution was unanimously adopted:

RESOLUTION NO. 1-81

RESOLUTION OF THE BOARD OF DIRECTORS OF

RIO LINDA WATER DISTRICT

APPROVING A LOSS-PREVENTION INSPECTION

WHEREAS, the Loss-Prevention Inspection is an integral part of a multi-faceted program aimed at controlling losses through inspections, recommendations and reporting, corrective actions, and total commitment on the part of member districts;

and

WHEREAS, said policy of Loss-Prevention Inspections was unanimously approved and adopted at the ACWA/JPIA Executive Committee meeting held January 11, 1980;

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of Rio Linda Water District (hereinafter called DISTRICT) that authority is hereby granted to the Association of California Water Agencies Joint Powers Insurance Authority (hereinafter called ACWA/JPIA) to arrange, schedule and contract for a Loss-Prevention Inspection of this DISTRICT.

BE IT FURTHER RESOLVED that DISTRICT understands and agrees that such Loss-Prevention Inspection is required by ACWA/JPIA as a precondition for consideration of acceptance into the 1981-82 Policy Year of coverage for the ACWA/JPIA commencing October 1, 1981, that expense for said Loss-Prevention Inspection shall be unconditionally borne by the DISTRICT, and that a copy of the Loss-Prevention Inspection report and recommendations will become the property of the DISTRICT whether or not the DISTRICT becomes a member of the ACWA/JPIA.

BE IT FURTHER RESOLVED that the Board of Directors of this DISTRICT presents this reclution to the ACWA/JPIA Executive Committee as a request to proceed with the Loss-Prevention Inspection, and as authorization for same. It is understood that all districts seeking participation in the 1981-82 ACWA/JPIA Policy Year have a deadline date of May 1, 1981, for compliance with all necessary requirements and procedures as set forth by the ACWA/JPIA for new members, and that therefore time is of the essence.

Mr. Adams reported that some developers have shown interest in a water line at 26th and Que Streets. It would be about 3,800 feet of water line. The board discussed the possibility of rebating to the customer who pays for the line when someone along the line connects to it. After much discussion, Mr. Palmer moved that the district policy for any line extensions will be that any extension will be paid by the consumer and that no rebate will be given. Mr. Dyer seconded the motion and it was unanimously adopted.

The manager reported that Patricia Torres was in a severe automobile accident and is hospitalized. The extent of her injuries are unkown at this time.

We have received the money from the Federal Block Grant people for the completion of Well No. 9. That project will be completed in the near future.

The plans for the addition to the office are presently at a standstill because of the workload. However, the utilities are being moved to new locations in anticipation of the extension.

Mr. Adams reported that he had talked to Mrs. Thorn regarding the purchase of her property next to the District property. He offered her the use of her home for the remainder of her life. She will consider the offer and let him know her decision.

Mr. Unger's suit against this water district was disallowed because he failed to appear in court.

Mr. Adams announced that Janelle Smith has been appointed to the Association of California Water Agencies' legal affairs committee. She is desirous of attending the Spring Conference in Anaheim, California in May. The board agreed that Mr. Adams and Mrs. Smith should be able to attend this conference.

Mr. Weber reported that the last meeting of the Association was a dinner meeting. The program was a film on Solar Energy.

There being no further business Mr. Dyer moved the meeting be adjourned.

Mr. Wilson seconded the motion and the meeting was adjourned.

Mr. Wilson moved that the Treasurer of the County of Sacramento be authorized and directed to pay out money of the District in the total sum of \$23,659.65 drawn on the Water Maintenance and Operations Fund and as represented by Request for Warrants numbered W6424 through W6453, each of which has been signed by a majority of the Board of Directors. This motion was seconded by Mr. Dyer and passed unanimously.

The subject of the district election in November was discussed. The terms of Mr. Weber and Mr. Wilson will expire.

On motion by Mr. Palmer and second by Mr. Wilson the following Resolution was unanimously adopted.

RESOLUTION NO. 2-81

RESOLUTION CALLING GENERAL DISTRICT ELECTION

WHEREAS, an election will be held within the RIO LINDA WATER DISTRICT on November 3, 1981, for the purpose of electing members to the District Board of Directors; and

WHEREAS, whenever two or more elections are called to be held on the same day, in the same territory, or in part of the same territory, such elections should be consolidated;

NOW, THEREFORE, BE IT RESOLVED that the RIO LINDA WATER DISTRICT requests the governing body or officer of the County of Sacramento, as prescribed by Elections Code Section 23301.5, to consolidate the regularly scheduled district election with any other elections to be held on November 3, 1981; and

BE IT FURTHER RESOLVED, that the Candidate is to pay for the publication of the Candidate's Statement, pursuant to Elections Code Section 10012. The limitation on the number of words that a candidate may use in his/her Candidate's Statement is 200 words; and

BE IT FURTHER RESOLVED, that the RIO LINDA WATER DISTRICT agrees to reimburse the Registrar of Voters for actual costs accrued for each election, such costs to be calculated by proration method set forth in the County's current Election Cost Allocation Procedures on the basis of the amount of services provided to the Rio Linda Water District.

The Board agreed that the Registrar of Voters should publish the election notice in the Sacramento Union in conjunction with other elections in the district. However, Mr. Crane moved that a letter regarding the election be sent to the Rio Linda World for publication. This motion died on the floor for lack of a second.

Mr. Signorotti presented his report for the months of February and March, 1981 and explained them in detail. Copies of the proposed budget for the FY1981-82 were brought before the board for discussion. Mr. Signorotti explained how the figures were arrived at. Action on the budget will take place the meeting in June.

Construction on Well No. 9 will begin about the first of June.

Mr. Adams will meet with Walt Libal at Arcade Water District concerning some kind of working arrangement to furnish water to 30th and Que Streets. He will report to the board at the next meeting.

A letter was read concerning the findings of the ACWA/JPIA findings. Before any action can be taken we must determine the cost of items not covered by this policy.

The board of directors voiced their opposition to Assembly Bill 1192 regarding the establishment of a nine-member California Municipal Debt Advisory Commission. The requested that the manager write a letter to the members of the Assembly Ways and Means Committee at the State Capitol urging a NO vote on this bill.

Mr. Weber reported that the best news of the Association meeting was that no dues would be assessed the districts for 1981.

He commented on Walt Libal's report from the Conservation Committee. The "Gutter Flooder" program is going great.

He noted that fire protection charges were appearing on some water agency water bills as a separate charge from monthly service charges and lised as Fire Protection Surcharge. The next meeting will have the discussion of the salary and benefits survey.

 $\mbox{Mr.}$ Dyer moved the meeting be adjourned. $\mbox{Mr.}$ Wilson seconded the motion and the meeting was adjourned.

WHEREAS, a portion of State Highway 99/70 from Interstate 5 north to the 99/70 Y, also known as El Centro Road is within Sacramento County:

WHEREAS, this section of State Highway 99/70 has been the location of numerous accidents resulting in 44 injuries and 17 fatalities on the southern 5 mile section since February 1978; and

WHEREAS, this section of State Highway 99/70 is used by over 11,500 vehicles per day in an area where driving conditions are impaired by seasonal fog, agricultural smoke, high speed traffic, high intensity of large trucks, and heavy intersecting traffic; and

WHEREAS, even though this section of highway has been given top priority for improvement since 1975, the California Transportation Commission has decided in each of these years that permanent safety improvements for this stretch of highway was not considered a priority; and

WHEREAS, our employees and vehicles use this section of highway regularly and encounter numerous incidents of near tragedy and mental anguish,

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of RIO LINDA WATER DISTRICT officially request that the California Department of Transportation and the California Transportation Commission designate the highest possible priority to the permanent improvement of State Highway 99/70 from Interstate 5, north to the 99/70 Y and to grant this extremely dangerous section of highway full freeway status.
